RESOLUTION NO. 2014-1 (CITY OF ATTICA, INDIANA)

This joint resolution which assigns Fountain County's interest in certain real estate and the acceptance of that assignment in real estate by the City of Attica is entered into pursuant to IC 36-1-11-8.

WHEREAS, IC 36-1-11-8 permits a municipal unit to transfer real estate to another municipal unit provided that each municipal unit passes substantially like Resolutions,
