RESOLUTION AUTHORIZING TRANSFER OF INTEREST IN REAL ESTATE AND ACCEPTANCE OF INTEREST IN REAL ESTATE

RESOLUTION NO. 2014- 2 (CITY OF ATTICA, INDIANA)

This joint resolution which transfers Attica Consolidated School Corporation's interest in certain real estate and the acceptance of that interest in real estate by the City of Attica is entered into pursuant to IC 36-1-11-8.

WHEREAS, the Attica Consolidated School Corporation is the owner of the real estate set forth in this Resolution, and

WHEREAS, the Attica Consolidated School Corporation has agreed to transfer a non-exclusive easement to the City of Attica for the development of a public walkway under the Safe Routes to School Program, and

WHEREAS, the City of Attica has agreed to accept a non-exclusive easement to use said real estate for a public walkway as required for development under the Safe Routes to School Program, and

WHEREAS, IC 36-1-11-8 permits a municipal unit to transfer real estate to another municipal unit provided that each municipal unit passes substantially like Resolutions,

NOW, THEREFORE, BE IT RESOLVED that the Attica Consolidated School Corporation transfers a non-exclusive right to use for a public walkway real estate as set forth below to the City of Attica the following described real estate To-wit:

A part of the Southwest Quarter of Section 5, Township 21 North, Range 7 West, of the Second Principal Meridian, in Logan Township, Fountain County, Indiana and being all that part of the grantors land, lying within the right or way lines depicted on the Location Control Route Survey and Right of Way Parcel Plat marked EXHIBIT "B", attached herewith and made a part of this description by reference, described as follows:

BE IT FURTHER RESOLVED, that the School Board for the Attica Consolidated School Corporation be authorized to execute any documentation necessary to transfer title to the City of Attica.

BE IT FURTHER RESOLVED that the City of Attica is authorized to acquire the non-exclusive easement to the above described real estate, said real estate to be used exclusively and solely for the purpose of constructing and installing a sidewalk and crosswalk approach.

BE IT FURTHER RESOLVED that the President of the Attica Consolidated School Board and the Mayor for the City of Attica are authorized to execute any necessary documents required to carry out this resolution.
