RESOLUTION NO. 11, 2017

A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF ATTICA, INDIANA, APPROVING CERTAIN MATTERS IN CONNECTION WITH THE ESTABLISHMENT OF AN ECONOMIC DEVELOPMENT AREA AND AN ALLOCATION AREA AND THE APPROVAL OF AN ECONOMIC DEVELOPMENT PLAN FOR SAID AREA

WHEREAS, the City of Attica Redevelopment Commission (the "Commission"), as the governing body for the City of Attica Redevelopment Department (the "Department"), pursuant to Indiana Code 36-7-14, as amended (the "Act"), on November 20, 2017, adopted a Resolution (the "Declaratory Resolution") designating an area known as the "Attica Economic Development Area" (the "Economic Development Area"), as an "economic development area" pursuant to IC 36-7-14-41 and designated all of such area as an allocation area pursuant to Section 39 of the Act; and

WHEREAS, the Declaratory Resolution approved an economic development plan for the Economic Development Area (the "Plan"); and

WHEREAS, the Attica Planning Commission, on November 20, 2017, adopted a resolution (the "Plan Commission Order") determining that the Declaratory Resolution and the Plan conform to the plan of development for the City of Attica, Indiana (the "City"), and approving the Declaratory Resolution and the Plan; and

WHEREAS, pursuant to Sections 16(b) and 41 of the Act, the Commission has submitted the Declaratory Resolution, the Plan, and the Plan Commission Order to the Common Council of the City (the "Common Council").

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITTY OF ATTICA, INDIANA, as follows:

- 1. Pursuant to Sections 16(b) and 41 of the Act, this Common Council hereby approves, in all respects, the Declaratory Resolution, the Plan, and the Plan Commission Order.
- 2. This Common Council hereby approves the determination that the Economic Development Area is an economic development area pursuant to Section 41 of the Act and an allocation area pursuant to Section 39 of the Act.
 - 3. This resolution shall be in full force and effect from and after its adoption.
