COUNCIL PROCEEDINGS CITY OF ATTICA

4-1-2020

The Common Council for the City of Attica met by phone for a special public meeting on April 1st, 2020, at 6:00 P.M to discuss Covid-19 Ordinances that need put in place.

Those present at the meeting were: Council Members: Mr. Larry Grant, Mrs. Kaylie Carnahan, Mrs. Valarie Maus, Mrs. Patricia Hargan and Mr. Scott Voorhees. Also, present were: Mayor, Duane Roderick, Attorney Jud Barce, Attorney Ingrid Barce and Clerk-Treasurer, Joanne Broadwater.

NEW BUSINESS:

Attorney Jud Barce presented and explained the Covid-19 related Ordinances and Resolutions that the Attica City Council needed to discuss. They were presented in the following order:

Ordinance NO 2020-0401A- An Ordinance amending Ordinance #8, 2019 (An ordinance establishing wages and compensation for elected officials, appointed officials, employees and members of the Attica Police Department and Fire Department. The amendment was to provide pay for employees in certain declared emergency circumstances.

A Motion was made by Maus to approve this amendment and seconded by Hargan, all were in favor, motion passed.

Resolution NO 2020-0401B- A Resolution declaring a local public health emergency for the City of Attica, Indiana.

A Motion was made by Voorhees to approve this amendment and seconded by Maus, all were in favor, motion passed.

Resolution NO 2020-0401C- A Resolution adopting the City of Attica's Utility Billing Policy during the COVID-19 Pandemic.

A Motion was made by Hargan to approve this amendment and seconded by Grant, all were in favor, motion passed.

Resolution NO 2020-0401D- A Resolution Adopting the City of Attica's COVID-19 Employment Policy.

A Motion was made by Maus to approve this amendment and seconded by Hargan, all were in favor, motion passed.

Resolution NO 2020-0401E- A Resolution Amending the City of Attica's Employment Policy.

A Motion was made by Hargan to approve this amendment and seconded by Carnahan, all were in favor, motion passed.

City Attorney Jud Barce also handed out a document labeled "PAID LEAVE FOR COVID-19 REASONS" that explained the "Families First Coronavirus Response Act (H.R. 6201; P.L. 116-127). This Act amended and/or added various federal laws due to the COVID-19. These provisions are effective no later than 15 days after the Act was signed by the President, which would be April 2, 2020.

The final document provided was a form titled "REQUEST FOR PANDEMIC OR EPIDEMIC LEAVE AFFIDAVIT". This is the request form employees will use to request leave related to COVID-19.

A Motion was made by Grant to approve this document and seconded by Voorhees, all were in favor, motion passed.

ADJORNMENT:

Roderick stated he had no further business and requested a motion to adjourn. The next meeting of the Attica City Council will be Monday April 13th 2020 at 6:00pm.

Hargan made the motion to adjourn, Maus 2nded, motion passed, meeting Adjourned.
